The Contractor Must register with Construction Industry Development Board (CIDB) under category E7 – Internal Telecommunication & E8 - External Telecommunication for FTTH passive Infrastructures. 6. The Contractor Must register with MOF under category 210105 or equivalent related to ICT and Telecommunication 7. The above FTTH deployment shall include all necessary materials, accessories, peripherals, labelling etc. to reflect a complete installation, documentation, testing and commissioning. 8. The scope of works covers Fiber Cabling Works (fiber cable pulling, fusion splicing works and testing), supply & install, test and commission all necessary materials/accessories. 9.
